

# DECIPHER KENNEL'S STUD CONTRACT

**Decipher Kennel's** and \_\_\_\_\_ of \_\_\_\_\_, hereby agree to the following terms and conditions concerning the breeding of the two dogs listed below:

The owner of the **Dam** will pay the owner of the **Stud** a total fee of \$ \_\_\_\_\_. A security deposit of \$ \_\_\_\_\_ is due at the time of submission of this contract. Before breeding can take place the remaining balance of \$ \_\_\_\_\_ must be paid in full. This total DOES NOT include any vet cost. **Purchaser** agrees to pay all costs associated with completing the breeding; ex. shipping the female, and or the collection of semen for insemination, and or shipping of the semen, etc. This all is in addition to the stud fee. These costs are the responsibility of the **Purchaser** and will not be paid by **Decipher Kennels**. **Stud** credits purchased cannot be resold to any 3rd party or given/used by any other **Dam** owner other than the **Purchaser**. This **Stud** credit purchased can "only" be used on the **Dam** stated above. If **Dam** passes away or cannot be bred for any reason, the new **Dam** must be approved by **Decipher Kennels**.

**Purchaser** will be allowed up to two (2) repeat breedings if any of the following things were to occur: Breeding does not take, or the **Dam** has 3 or less pups. Therefore, a total of 3 breedings. If 3 breedings are unsuccessful after adequate quality semen is sent, then the **Dam's** owner will be granted one frozen breeding from **Stud**. The contract has then been fulfilled by **Decipher Kennels**.

In some situations we may ask for documentation to prove the **Dam** is not pregnant at our own discretion. If the **Dam** is confirmed pregnant we advise that you take your pregnant **Dam** to the vet on a regular basis while pregnant. Be sure to get an ultrasound and schedule a c-section if needed.

If at any time the **Dam** owner decides they no longer want to continue with this breeding, this contract will be terminated and no refund will be granted.
